## **CCYA Conditions of Membership**

*As a member of CCYA, I acknowledge as a condition of membership that I*

- *Will comply with the rules and conditions of the Association as defined in the Constitution*
- *Will comply with the minimum safety requirements of Waterways NSW whenever I am engaged in any CCYA-sanctioned activities*
- *Accept that at all times, as skipper of the boat or as its owner, I am responsible for the safety of my crew, my passengers, the boat and myself.*
- *Accept that it is my responsibility to have careful and considered regard to the prevailing and forecast conditions, my experience, that of the crew and the condition of the boat in deciding to commence motoring or sailing and whether or not I continue motoring or sailing.*
- *I will ensure that I have completed and complied with the requirements of the CCYA Conditions of Racing for that membership year – prior to entering or allowing my boat to be entered in any CCYA race to be sailed by my boat that year.*

## **CCYA Conditions of Racing**

*I acknowledge that:*

- *Yacht racing is a hazardous activity (that is it has risks) and by participating, I do so at my own risk.*
- *In participating, my crew has been made aware that yacht racing is a hazardous activity*
- *Appropriate insurance for injury (including death) to persons, and for damage to third party property in respect of use of my/the owner's boat is in place and will continue to be in place for racing.*
